He has a long track record in advising energy, oil and gas-sector clients in investment arbitrations involving Ukraine. Acting as an official member of the Ukrainian Government Negotiating Team, Mr Gryshko was also involved in developing and negotiating some of the core international treaties and agreements for the Government of Ukraine.
