

Litigation between an engineering company and an oil transmission system operator arising from an EPC for a 300 km pipeline project.

Our role: Counsel to Claimant.

The problem: Unforeseen circumstances prompted the employer to unilaterally seek renegotiation of contract terms. Subsequently, the employer repudiated the contract altogether, withholding payment for completed work. This posed a formidable challenge, threatening both the project's continuity and our client's financial stability.

The solution: We embarked on a multifaceted strategy to address the dispute. Leveraging our expertise in negotiation and litigation, we engaged in settlement discussions while simultaneously preparing for the dispute. The case involved various novel legal points, which we thoroughly researched and convincingly presented, including before the Supreme Court. As a result, we secured a full victory for our client, vindicating all claims with interest (which doubled the claims' value) and dismissing all counterclaims raised by the employer.

Arbitration between an owner of a combined cycle power plant project and an international financial institution.

Our role: Counsel to Claimant.

The problem: An international financial institution, acting as a guarantor, refused to honour the bond granted to a defaulting contractor. The impasse demanded swift and decisive legal action to enforce the terms of the financial guarantee and secure rightful compensation for our client.

The solution: We devised a focused and strategic approach to address the dispute. We opted to represent the owner in arbitration proceedings against the international financial institution, strategically excluding peripheral issues concerning the broader dispute between the project owner and the defaulting contractor. Through meticulous legal analysis and persuasive advocacy, we secured a winning award. Subsequently, we successfully collected the guaranteed amount for our client, thereby safeguarding their financial interests and preserving the integrity of the project.
